- 3. Ido not feel short of breath or have difficulty breathing in a way that is not normal for me.
- 4. Ido not have a new cough or cough that has worsened in frequency, severity, intensity or in any other way.
- 5. I do not have, nor experienced in the past 14 days, a new loss of taste or smell.
- 6. Ihave not been near family members or others who have tested positive for COVID-19 or who are ill or have experienced any of the above symptoms and have not visited anyone who is ill or had symptoms of fevers, shortness of breath, cough, or loss of taste or smell. Excludes medical personnel in situations where appropriate PPE is worn.
- 7. I have not tested positive for COVID-19 nor presumptively positive for COVID-19 based on my health care provider's assessment or my symptoms.
- 8. To the best of my knowledge, I have had no exposure to individuals with COVID-19, and I am not experiencing any COVID-19 symptoms.

COVID-19 has been declared a pandemic in the United States. COVID-19 has been shown to be extremely contagious. The state of medical knowledge continues to evolve, but the virus is believed to spread from person-to-person contact, by air and/or by contact with contaminated surfaces and objects.
